You must file this application with the Secretary of State's office only if the name of the owner of the mark has changed, not the ownership of the mark. Registrant must attach a true and correct copy of the original document showing proof of name change, or a copy of the original document filed in another jurisdiction and certified by the filing office of that jurisdiction.

Please indicate at the top of the application which type of registration is being assigned.

- Item 1.** Enter the complete name of the registrant as it was originally registered.
- Item 2.** Enter the complete business address as it was originally registered.
- Item 3.** Identify the business structure of the registrant as it was originally registered, by checking the appropriate box. If a corporation, limited liability company, limited partnership or general partnership, list the state of origination.
- Item 4.** Enter the names of the general partners as originally registered, if registrant is a partnership.
- Item 5.** Enter the trade/service mark registration number.
- Item 6.** Enter the original date of registration of the trade/service mark.
- Item 7.** Enter the name and/or description of the trade/service mark.
- Item 8.** Enter the new name of the registered owner of the mark.
